#### NOTES:

- 1 The above audited Financial Results were reviewed by the Audit Committee and approved by the Board of Directors at their respective meetings held on May 24, 2012.
  - The above published consolidated results have been exctrated from consolidated financial statements prepared in accordance with principles and procedures set out in Accounting Standard 21 on 'Consolidated Financial Statements' notified pursuent to Companies (Accounting Standards) Rules, 2006.
- 2 The Company acquired N. Kumar Diamond Exports Ltd.(NKDEL) along with its wholly owned subsidiaries w.e.f. January 20, 2011. In view of the said acquisition, consolidated figures for the current quarter are not comparable with the corresponding quarter of the previous year.
- In quarters prior to July 01, 2011 / previous years, on account of short period of processing and/or manufacturing, difficulty in identifying the stages of process, and the insignificant impact on valuation, work in process was classified as raw materials for the purpose of classification and valuation with effect from July 01, 2011. On account of increased volumes and refinement in the method of identification of the stages of process, management has indentified work in progress and has also allocated variable and fixed overheads based on the stages of completion.
- In respect of the stock of loose polished diamonds due to numerous number of assortments and reassortments to multiple grades,in view of management, it is not practicable to compute the cost of loose polished diamonds using either first in first out, weighted average cost or Specific Cost. Inventory as at the year end is based on management's best technical estimate of replacement cost of the respective grade of diamonds. The basis of computing cost, is not in accordance with the method prescribed by Accounting Standard (AS) 2 "Valuation of Inventories impact whereof on the profit for the year, reserves and surplus and inventories as at 31 March 2012 could not be ascertained".
- Housefull International Limited, the wholly owned subsidary which in furniture business follows the policy of recognizing revenue on billing to customers and receipts of consideration. However, these items may be delivered at a later date resulting in risk not being transferred until the delivery is complete. The Company is consistently following the said practice. In view of the auditor, the same is not in accordance with the principles of revenue recognition laid down in Accounting Standard 9 Revenue Recognition and accordingly qualified the auditors report. As at the year end after considering the effect of previous year, the net impact of this results in sale being higher by ₹ 71.24 Lacs, and the profit for the year being lower by ₹ 38.37 lacs
- 6 The figures for the quarter published March 31, 2012 and March 31, 2011 are the balancing figure between the audited figure in respect of the full financial year and the year to date figures upto the third quarter.
- 7 The Board of Directors have recommended a final dividend @15% i.e f ₹ 1.50 per equity share.
- 8 Previous period's/ year's figures have been re-grouped / re-arranged wherever considered necessary, to corrospond with those of the current period's/ year's classification for disclosure as per the revised format set out in clause 41 which corresponds to the revised Schedule VI of the Companies' Act, 1956.
